PRESIDENT'S MESSAGE

he provincial legislation aimed at combatting insurance fraud (Bill 171) died when the election was called for June 12, 2014. That Bill sought tighter controls over tow truck operators and health clinics, amonast others, in an effort to reduce the amount of fraud present in the auto insurance sector. The promised auto premium reductions are in large part dependent on reducing costs in the system and instances of fraud in the sector. While it is unclear if the legislation or something comparable will be re-introduced by the new government, brokers can still play an important role in fighting fraud through:

- · sensitivity to circumstances surrounding a claim that suggest something is not quite right, for example, staged accidents
- · generally, having a second look where client activity seems to indicate some fraudulent purpose.

Both FSCO and the IBAO have created excellent materials which seek to educate

the public on auto insurance fraud. We encourage brokers to make use of these materials by having them available in your office, on your websites, etc. Further, brokers are encouraged to report good faith concerns about potential fraud to insurance companies, regulators and, where appropriate, the police.

Also with respect to auto insurance, brokers have an ongoing obligation to review with their clients the optional benefits available, Have a safe and enjoyable summer season.

Qualification and Registration Committee Report

As the temperature is warming, a nice summer is arriving. As with every summer, it is renewal season. Each individual is responsible for renewing their RIBO license by the August 31st deadline.

Paper renewals will not be sent out as it is a August 31st. It is highly recommended that the mandatory online renewal this year. Renewing online is faster and more efficient for yourself and RIBO. For those who have renewed online in prior years, the process and user information/login remains the same. If this will be your first time renewing online, please go to www.ribo.com, "Member Login" (at the top right corner) to set up online access. Please refer to the 2014-2015 Renewal Process page for more information about the 2014/2015 renewal.

It is important to note that many individual follow-ups are a result of incorrect answers on the renewal application. Please read and answer each question carefully.

To comply with the requirements, all continuing education hours for the renewal must be completed by September 30th in order to avoid a license suspension. This deadline is not to be confused with the renewal deadline of

hours be completed early to reduce pressure and stress. If you have partially completed the required hours or are in the process of completing the hours, you are still required to complete the application and pay the renewal fee by the deadline, but must answer "NO" to the continuing education question. Answering otherwise is an act of misconduct and falsification of the renewal form.

Over the last three months we reviewed 61 requests for secondary business exemptions. The exemption breakdown was as follows: 6 individuals were granted exemptions to sell financial products and 55 individuals were granted other secondary business exemptions.

Broker Disputes Over Portfolio Rollover

RIBO has experienced an increase in the number of complaints emanating from brokers regarding the difficulties they are experiencing when trying to make a portfolio transfer from one registered brokerage firm to another.

In spite of the existence of a contract between the brokers, quite often the relationship between the parting brokers breaks down in the early stages of the portfolio rollover. It is not unusual in these situations for one broker or the other to bring the matter to RIBO along with allegations of misconduct against the other broker.

If this happens, RIBO will investigate the conduct of all parties involved to determine if possible misconduct has occurred.

In general, RIBO does not get involved in contractual disputes between brokers, as the ordinary civil remedies apply. However, RIBO will get involved if there is consumer exposure as a result of these disputes.

Brokers are reminded that during any portfolio rollover all parties are required to act in a professional manner and should assist in any possible way to make certain that there is a smooth and seamless transfer for the files and that consumers are not left exposed in any way.

Please refer to the RIBO Principal Broker's Handbook. The supplementary resources section (pages 6.2 through 6.5) provides guidelines to assist brokers when transferring portfolios.

The 33rd Annual Meeting of members of the Registered Insurance Brokers of Ontario will take place on Thursday, November 6, 2014 at 1:30 p.m. at the Arcadian Loft, 401 Bay Street, Simpson Tower, 8th Floor, in downtown Toronto. A formal notice of meeting and proxy, along with the election material, will be mailed to each registrant in good standing in early October. All registrants are eligible to attend and to vote on matters properly brought before the meeting.

RATING OF SEASONAL VEHICLES

As the summer months are almost upon us, RIBO would like to remind brokers about the opportunity to talk with your clients about seasonal vehicle rates calculation as well as possible cancellation penalties for policies cancelled mid-term. As many seasonal vehicle riders, this being motorcycle, snowmobile or any other seasonal vehicle, are looking for insurance for the first time, they may not be aware of how the seasonal rates are calculated. They may also not be aware of the type of cancellation penalties involved when they request a policy to be cancelled at the end of the season. Many experienced riders who have had insurance for a number of years may also have forgotten about the cancellation penalties involved when a policy is cancelled mid-term.

The time of writing up a new application or offering a renewal policy is a perfect time to inform or remind clients about the seasonal rates, earned premium calculations as well as cancellations and short rate penalties. Brokers are also encouraged to keep proper file documentation at all times, not only limited to seasonal vehicles.

Notice of Election of Council Members

Notice is hereby given that the annual election of council members will be held on Monday, November 3, 2014 at which time three council members are to be elected for a term of three years.

Registrants have the opportunity to nominate candidates, including incumbents if they agree to have their names put forward for election to serve another term. Candidates for election will be divided into two streams. Those from firms with 20 or more licensed individuals and those from firms with less than 20 licensed individuals. A nomination form with instructions is enclosed in this edition of the Bulletin. Eligibility for election is set out in RIBO By-law No. 21, Section 1 (2) as follows:

Each person who is an individual member of the corporation (RIBO) and,

- a) who is qualified to vote at an election of Council, (a person is registered under the Act and not in default with respect to payment of fees),
- b) who is a Canadian citizen ordinarily resident in Ontario or a permanent resident within the meaning of the Immigration Act, 1976 (Canada) and ordinarily resident in Ontario, except a permanent resident who has been ordinarily resident in Ontario for more than one year after the time at which they first became eligible to apply for Canadian citizenship,
- c) who is nominated in accordance with Section 8,
- d) whose conduct is not the subject of a complaint referred to the Discipline Committee, or the subject of disciplinary proceedings before the Discipline Committee,

is eligible to stand for election to the Council in accordance with this By-law.

Nominations, a brief biography (under110 words), outlining professional qualifications and record of community service, and a photograph must be received in writing by the Manager at the RIBO office no later than 4:00 p.m., on September 15, 2014.

In early October, each registered insurance broker will receive a list of nominated candidates. The nomination bio sheet will be accompanied by a ballot form and a return envelope to be delivered to the RIBO office to the attention of the Manager, no later than 4:00 p.m. on the date of the election, November 3, 2014.

2014 - 2015 Renewal Process

As previously announced, beginning with the 2014/2015 renewal term, **all** renewals will be processed **online only** and paper renewals will no longer be available. Each individual must have a current, unique and valid email address (not a common corporate email account). Without a unique and valid email address the online renewal process cannot be completed. **Please add the email domain "ribo.com" onto your email Safe Senders list or Address Book/Contacts.**

The online renewal portal will be available on July 1, 2014. It is the Principal Broker's responsibility to ensure that the renewal application form for the firm is properly completed and submitted. While it remains the responsibility of each individual member to ensure that his or her registration is renewed, Principal Brokers are expected to ensure that all individuals associated with the firm renew their registration and comply with the continuing education requirements.

DEADLINE to renew for the 2014/2015 term is August 31, 2014. The 2013/2014 licenses will expire on September 30, 2014. Any licenses not renewed by the expiry date will be lapsed and will be subject to a \$170 penalty fee, in addition to the registration and reinstatement fee, to reinstate the license.

MISCONDUCT: Ont. Reg. 991, ss. 14(1) and 14(3)

PARTICULARS OF THE COMPLAINT:

Richard Bretzlaff failed to forward an application for home insurance to an insurer resulting in a lack of coverage.

DISCIPLINE COMMITTEE'S DISPOSITION

Mr. Bretzlaff entered a plea of guilty and the Discipline Committee accepted the evidence adduced by RIBO in support of the plea of guilty. Accordingly, Richard Bretzlaff was found guilty and the Discipline Committee orders:

- (a) That the Certificate of Registration of Richard Bretzlaff be and is hereby suspended for eighteen (18) months effective January 30, 2014.
- (b) That a recommendation be made to the Qualification and Registration Committee that the Certificate of Registration of Richard Bretzlaff be restricted to acting under supervision and that they not consider any application by Mr. Bretzlaff to change his registration from acting under supervision for a period of no less than 5 years from the date of this Decision.

HEARING DATE: February 27, 2014

MISCONDUCT: Ont. Reg. 991, ss. 15(1)13, 6(4) 4i and ii, 5 and (6).

PARTICULARS OF THE COMPLAINT:

Affirm Business Centre Insurance Brokers Inc. (hereinafter referred to as "Affirm Business Centre") and Christa Ann Pissey as Principal Broker, has been in breach of an Order of the Discipline Committee dated the 7th day of June, 2012, wherein Affirm Business Centre was ordered to file monthly position reports in Form-1 showing full compliance for a period of 1 year, commencing with the month ending July 31, 2012, and thereafter as at August 31, 2012, September 30, 2012, October 31, 2012, November 30, 2012, December 31, 2012, January 31, 2013, February 28, 2013, March 31, 2013, April 30, 2013, May 31, 2013 and June 30, 2013, with usual attachments. Upon review by RIBO staff Ms. Christa Ann Pissey continued to make transfers from the trust account to the general account, at the beginning of the month that exceeded the previous months net trust position resulting in a net trust deficit at the beginning of the month. Broker was advised formally in writing on January 15, 2013 to ensure adherence to the regulations. Upon a broker review on March 12, 2013 RIBO staff established that the

above practice continued. Therefore Christa Ann Pissey and Affirm Business Centre are in breach of the Order dated June 7, 2012.

DISCIPLINE COMMITTEE'S DISPOSITION

The Discipline Committee found that there was sufficient evidence for the plea of guilty by Christa Ann Pissey personally and on behalf of Affirm Business Centre, and accepts the evidence adduced by RIBO in support of the plea of guilty and finds that Ms. Pissey and Affirm Business Centre are both guilty of the misconduct as alleged.

The Panel heard submissions from Counsel for RIBO and from Christa Ann Pissey with respect to both penalty and publication. RIBO's outside Counsel noted that Ms. Pissey was an experienced broker and has been registered since October 24, 1984. Furthermore, he argued that the previous disciplinary Order dated June 7, 2012 was not followed; the seriousness of the previous action was not recognized and insufficient steps taken to remedy the situation. The Discipline Committee therefore orders:

- (a) That the Certificate of Registration of Chista Ann Pissey is hereby restricted to Y Unrestricted Technical Only (Discipline Order). This restriction to be in effect immediately or at which time a new Principal Broker of Affirm Business Centre can be appointed. In either case this restriction to be in effect no later than 60 days after the Order of the Discipline Committee has been ratified.
- (b) That a recommendation be made to the Qualification and Registration Committee that the Certificate of Registration of Christa Ann Pissey be so restricted for a period of not less than three (3) years. Should Ms. Pissey wish to remove the restriction at that time, she must first attend the IBAO Advanced Broker Management Course and pass the RIBO Unrestricted Management Exam to be set by RIBO.
- (c) That Affirm Business Centre file monthly position reports in Form-1 showing full compliance for a period of 3 years commencing with the month ending April 30, 2014 and finishing with the month ending March 31, 2017 and to be accompanied with the usual verifying financial attachments.
